- \* Building, electrical, mechanical and plumbing inspections are required and must be called for and approved before a building can be occupied.
- \* Failure to pay permit fees or submit a contractor's license and certification before the first required inspection will result in a \$50.00 penalty.
- \* There will be a \$15.00 re-inspection fee for re-inspections of improper work. These must be paid before a final inspection is performed.
